### Clean Team Agreement

We refer to the clean team agreement dated 22 May 2026 (the “**Clean Team Agreement**”) between Intertek Group plc (“**Intertek**”) and EQT Fund Management S.à r.l.<sup>1</sup>, acting in its capacity as manager (gérant) on behalf of EQT X EUR S<sup>2</sup> and EQT X USD SCSp<sup>3</sup> (collectively referred to as “**EQT**”), a copy of which is attached hereto. Defined terms used but not defined herein shall have the meaning assigned to them in the Clean Team Agreement.

Platinum Ivy hereby acknowledges that it wishes to receive access to Clean Team Information in relation to the Potential Transaction, in consideration for which it undertakes to Intertek that it shall comply with and be bound by the terms of the Clean Team Agreement in accordance therewith as if it were EQT, provided that, in relation to Clauses 2.1 and 2.2 of the Clean Team Agreement, with respect to Platinum Ivy, Clean Team Members shall be made up only of the employees, directors or officers of Platinum Ivy and its affiliates and their external advisers listed in Annex A, and Annex A may be amended from time to time in accordance with Clause 2.1 of the Clean Team Agreement.

### Miscellaneous

Other than with respect to the matters specifically addressed herein, this agreement shall not create any legal obligation of any kind between the parties with respect to the Potential Transaction or otherwise.

Platinum Ivy acknowledges that Intertek makes no representations or warranties, express or implied, with respect to the Clean Team Information and shall not have any liability to Platinum Ivy or any of its

affiliates resulting from the selection or use of the Clean Team Information or any errors therein or omission therefrom.

### **Governing Law and Jurisdiction**

This agreement is to be governed by, and construed in accordance with, English law. Any matter claim or dispute arising out of or in connection with this agreement, whether contractual or non-contractual, and the relationship between the parties and the conduct of any negotiations in relation to the Potential Transaction are to be governed by and determined in accordance with English law. Each party hereby irrevocably submits to the exclusive jurisdiction of the English courts in respect of any claim or dispute arising out of or in connection with this agreement or the relationship between the parties or the conduct of any negotiations in relation to the Potential Transaction.

### **Agent for Service**

Platinum Ivy hereby irrevocably appoints TMF Global Services (UK) Limited of 13th Floor, One Angel Court, London, EC2R 7HJ to be its agent for the receipt of any claim forms, application notices, orders or judgments ("**Service Documents**"). Platinum Ivy agrees that any Service Document may be effectively served on it in connection with any proceeding, suit or action arising out of or in connection with this agreement, whether contractual or non-contractual, and the relationship between the parties and the conduct of any negotiations in relation to the Potential Transaction in England and Wales by service on such agent effected in any manner permitted by the Civil Procedure Rules. If such agent at any time ceases for any reason to act as such, Platinum Ivy shall appoint a replacement agent having an address for service in England or Wales and shall notify Intertek of the name and address of the replacement agent. Failing such appointment and notification, Intertek shall be entitled by notice to Platinum Ivy to appoint a replacement agent to act on its behalf. The provisions of this paragraph applying to service on an agent apply equally to service on a replacement agent.

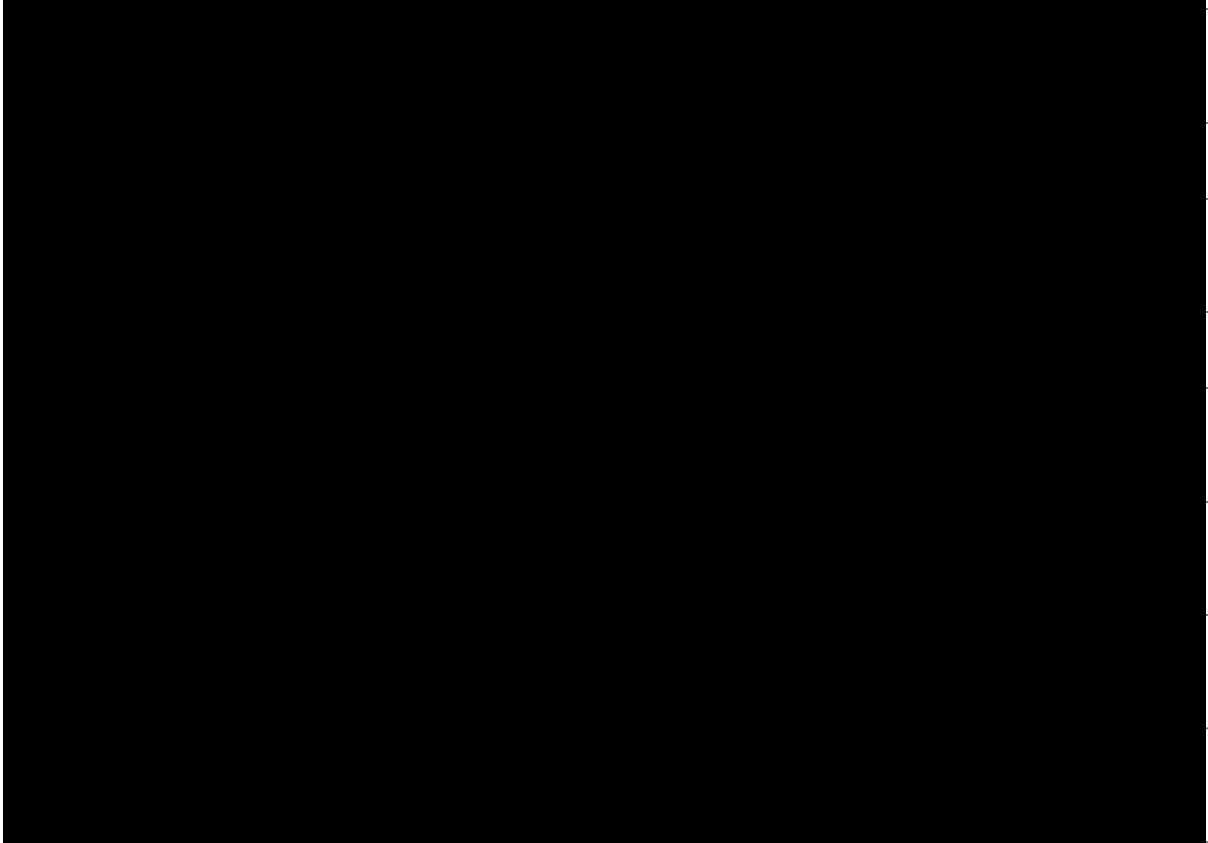
